## Create Your Jewish Legacy (CJL) Shows Early Successes

The Create Your Jewish Legacy initiative is off to a great start. To date, this communitywide program has resulted in 20 donors and families (see the adjacent list) creating 42 unique legacy gifts to support the Jewish organizations that serve our community and have special meaning to the donor and their families. These legacy gifts represent an estimated \$1.5 million of future gifts to our Jewish community. What is a legacy gift? It is a commitment to establish a deferred gift (a gift after death) to support those Jewish organizations that you supported throughout your lifetime. And, if you ask any of the legacy donors, each of these individuals will tell you how easy it was to establish and that it had no impact on their annual giving. All it takes is an update to your will or a beneficiary change in the beneficiary designation of your life insurance policy or retirement

While we are off to a great start it is only the beginning. This initiative will help create a culture of legacy giving where each of us will be asked to consider how we will be remembered and which organizations will remember us.

Our early successes have been realized because of the hard work of each of our ten community partner organizations and their CJL teams. These teams, comprised of more than 50 lay and professional leaders, meet on a regular basis. They have attended three community training sessions and have either established or will establish legacy gifts of their own.

"Temple Israel is proud to be an active participant in CJL," said Barry Bobrow, Temple Israel's Board President and member of their CJL team. "Working proactively with our members regarding legacy gifts is an important way for us to assure the long term viability of our congregation. The FCJC leadership has been strong and we're really seeing the momentum build for our legacy gifts and those for all of the participating groups."

It is important to remember that our CJL effort was designed to follow the model that has resulted in successful legacy programs in many Jewish communities throughout the country. This model, in addition to the individual team and community training sessions, requires that each of the ten community partner organizations create their own case statements and legacy plans. The case statements describe the importance of legacy gifts to an organization's future success. These case statements will soon be available on the web sites of each CJL community partner organization by clicking on the CJL website


