Diversity Development, Procurement Program

The program will ensure gay and lesbian owned businesses have increased opportunities for procurement contracts with Corporate America, Working with corporations and their diversity supplier managers, NGLCC will serve as the only certifying organization for the purposes of procurement contract opportunities. The NGLCC and the DDPP will be the main bridge between Corporate America and gay and lesbian owned businesses and entrepreneurs.

Financial Services Partnership Program

The Financial Services Partnership Program was designed to give NGLCC members access to capital to start or grow their businesses.
