FISHING LICENSE REQUIREMENTS


All persons over 16 years of age who fish by pole and line or rod and reel outside of their county of residence must have in their possession a valid State fishing license or daily permit. A license is required before fishing in one's county of residence if artificial bait is used.

All non-residents over 12 years of age must obtain a non-resident, state-wide annual fishing license, a non-resident 5-day permit, or a non-resident daily permit before fishing in the waters of this State.

Members of the armed services who are residents of North Carolina and are on furlough are not required to possess a fishing license. Veterans who served overseas and are stationed at a Veterans' Hospital or facility and undergoing treatment there are not required to possess a fishing license. This provision is in force for the duration of World War II and 6 months thereafter. Non-resident members of the armed forces, assigned to active duty at a military facility in North Carolina, are entitled to purchase resident State fishing licenses without regard to State residence requirements.

A landowner and members of his family under 21 years of age may fish on their own property without the requirement of fishing license.

Six months' habitation in any county is necessary to constitute legal residence in that county.
