Carrie Ann Bowen, Former Speaker of the House, formally resigned a few weeks ago at the last House SGA meeting. As such, Karen Love has filled in as interim Speaker until a new Speaker of the House is elected.

The Speaker of the House is the figurehead of the House. They are charged with running the House meetings set by the SGA constitution. This position is also responsible for representing the voice of the House on the Senate. Also, their primary duty is to keep tabs on all the clubs and organization the SGA sponsors in order to make sure they are following the standards set by the Student Government as well as the school. These are not the only duties that the Speaker of the House is required to fulfill, but it is the core of the position.

When I am elected the next Speaker of the House in Spring 2009, I will continue the revisions Karen Love has started. I will help to unify the House, and work towards strengthening the SGA community.

Brevard College has endured trials of character and function throughout its history and this point in time is no exception. This era of growth and change in students' lives is reflected by events in national and international arenas. Those in attendance were working overtime, wearing as many hats as their heads could hold and receiving little help from the rest of the student body.

Which leads me to why I've decided to run for Speaker of the House: as an 8 year Americorps veteran, I've worked to establish learning centers in inner cites, designed and operated disaster relief centers, renovated homes for the economically disadvantaged, restored national park trails, legally challenged the Department of Homeland Security for rights transgressions, and EVEN taught kindergarten. The leadership skills developed during these treasured and toil-filled years have served me well at Brevard College thus far. However, I feel it is time that I brought the entirety of my capabilities to the table.

I will operate as Speaker of the House in three major ways: 1) restore operational efficacy to S.G.A. by providing a strong voice for the student body to the student congress; 2) cultivate a relationship between club representatives, the Executive Board and the student body to ensure that policies and procedures are both effective and adhered to; and 3) prevent the operations of S.G.A. from falling into disrepair by establishing a degree of transparency in operations that will allow any student to easily become a participant.
