FORUM Banned in the USA



Ban the 2 Live Crew! Ban Andrew Dice Clay! Ban Huckleberry Finn! Ban Playboy! -- It's all the same.

As an avid fan of the 2 Live Crew, freedom of speech and freedom of artistic expression, I applaud the Orange County District Attorney Carl Fox's decision to reverse his ban on the 2 Live Crew. It is obvious to anyone who sincerely believes in the U.S. Constitution and the Bill Of Rights that the banning of the 2 Live Crew's "As Nasty As They Wanna Be" is unconstitutional and to some degree discriminatory. Sure, "As Nasty as They Wanna Be" is of a "mature" nature. But just as rated R movies read at the beginning"This movie has been rated R by the motion picture association of America. It is intended for mature audiences only" so too reads 2 Live Crew's album- "this album

contains explicit lyrics". What's wrong then America? Can't a black man make money? Can't people choose to buy what they please as long as they do not infringe upon the rights and privacy of others?

Under N.C. General Statute 14-190.1, material is considered obscene if it:

(1) depicts or describes in a patently offensive way sexual conduct.

(2) the average person applying contemporary community standards would find that the material taken as a whole appeals to the prurient interest in sex

(3) lacks serious literary, artisitic, political or scientific value

(4) is as used un-protected or un-privileged under the U.S. Constitution of North Carolina.

By this statute, which is highly subjective and therefore at the whim of any wealthy or otherwise priviledged person or party, shouldn't Playboy be banned? Shouldn't the tapes of people such as Andrew Dice Clay be banned? What about the Ku Klux Klan? What about Tom Sawyer and Huckleberry Finn? All of these examples are offensive and/or depict or describe sexual conduct in a patently offensive way or lack serious literary, artistic, political or scientific merit according to some one. There are 250 million people in the U.S.; we all can't agree. But we shouldn't let the average person (white) applying contemporary community standards (middle class) be the person (male) to make judgements on what is art and what is not

To put it simply, if the 2 Live Crew were as wealthy as Hugh Hefner, Bob Guccione, or as Italian as Andrew Dice Clay, they could be as nasty as they wanna be. In the land of the free and the home of the brave, we (all "true" Americans) should fight the powers that be so the 2 Live will not be banned in the U.S.A.
