The Money Lab, aimed at teaching people how to manage their money and how to get the most from their paychecks, is open each Tuesday and Thursday night from 7:30 to 9 p.m. It is free.

Doris Lindsay from the agency office is in charge of the sessions. Materials such as slides and tapes are available as "help yourself" guides.

During August the consumer lab will be located in the Turnkey III center, 505 Habersham Road. Those who attend these sessions may come as often or as seldom as they choose.

The main office of Consumer Credit Counseling is located at 142 Church Avenue. Its services are also offered free of charge to all those who are having problems with money.

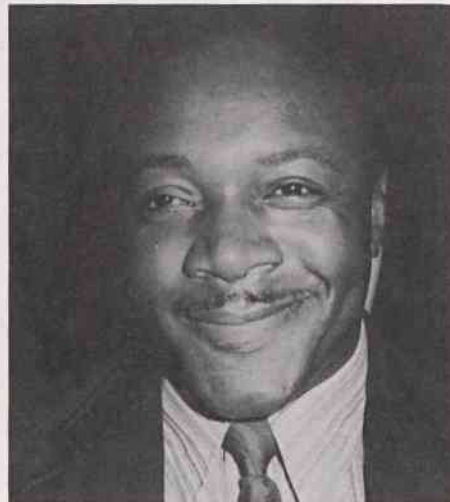
