



called State Student Legislature which later became the North Carolina Student Legislature which later became the North Carolina Student Legislature. The S.S.L. was concerned with issues of state and national importance. It was not until 1945 that a measure to invite "Negro Colleges" to all future sessions was passed. Consequently the attendance dropped (of white colleges) and on October 30, 1947 the S.S.L. was disbanded by its white officers, but was re-established in November, 1947, and new guidelines were set. As a result, by 1956 it was apparent that the State Student Legislature was here to stay. The S.S.L. became increasingly involved with controversial racial issues, which resulted in a walkout of all black institutions. As of 1971 the S.S.L. finally became the North Carolina Student Legislature, which continued to emphasize state issues, but also began making internal changes. In 1974 Fayetteville State University, along with other predominately black institutions became chartered members of the North Carolina Student Legislature.

The N.C.S.L. dedicates itself to work with the General Assembly (Student Legislature) for constructive changes and improvements of the government of the state. The N.C.S.L. provides learning opportunities of legislative processes and represents all people (students).

The Fayetteville State University delegation is young but full of ideas. We are largely concerned with making the community and campuses aware of the importance of politics on the local, state and national level. The lack of local turnouts at the polls has caught the eye of the F.S.U. delegation. As a result, our project for the 1975-76 year is Voter Registration. We hope that through this project we can increase the number of voters at the polls.

Realizing the many changes and advancements which need to be made at F.S.U., our delegation is drafting a bill for the allocation of additional funds to smaller state supported institutions. Our main purpose being to bring small, state supported institutions within the range of competition with larger state supported institutions.

The service which the Fayetteville State University delegation will be giving the community and campus is one which is so badly needed. Please become aware and get involved.
