FSU-backed Biz Center works to help local businesses

Since then, it has served the City of Fayetteville and the Murchison Road community as a business incubation center.

According to the center, the purpose of business incubators is to provide "comprehensive support to companies in their start-up stages, help entrepreneurs achieve their dreams, and help communities develop more vibrant economies."

"It provides a wonderful opportunity for the growth of these businesses," says FBC director Floyd Shorter. He is also a professor of business at FSU.

The "business incubator" model provides a multitude of services to businesses. These services might include things like "marketing assistance, help getting ready for financing, innovation assessment, legal direction, help with intellectual property issues, one-on-The Fayetteville Business Center one mentoring, use of lab space, help

with building a management team, venture capital forums, and many other things." The program has also worked as an internship opportunity for Fayetteville State students.

Mr. Shorter believes that the work done for local businesses is rewarding. "[I like] providing a service to them and seeing them grow," he says.

"It's almost like seeing a small child start out crawling and watching them grow up."


The business center currently serves over 100 businesses throughout the community and is constantly looking to help others. They are located at 2520 Murchison Road and can be contacted at 910-222-8910.

Holocaust Expert to Speak

Dr. Patricia Heberer, a renowned expert on the Holocaust, will present a lecture on "Nazi Ideology and Eugenics" on Monday, March 31, at 7 p.m. in J.W. Seabrook Auditorium on the Fayetteville State University campus. Admission is free and open to the public.

Dr. Heberer has served as an historian with the Center for Advanced Holocaust Studies at the United States Holocaust Memorial Museum in Washington since 1994. There, she functions as the Museum's in-house specialist on medical crimes and eugenics policies in Nazi Germany.

Dr. Heberer earned her bachelor and master's degrees from Southern Illinois University. She pursued doctoral studies at the Free University of Berlin and the University of Maryland, receiving her Ph.D. from the latter institution.

A contributor and consultant historian for two United States Holocaust Memorial Museum publications, "1945: The Year of Liberation" and "In Pursuit of Justice: Examining Evidence of the Holocaust," she is currently in the final stages of producing a history of the Hadamar "euthanasia" (T4) facility for publication. A further publication, "Atrocities on Trial: The Politics of Prosecuting War Crimes in Historical Perspective," co-edited with Juergen Matthäus, appeared this year (2008) with the University of Nebraska Press.
