Dear members of the Faculty, The Student Body, and the Administrative Staff:

Once again the Dana Scholarship Committee must begin its evaluation of nominees for Dana Scholarships for the next academic year. It is very important that you participate in the nomination of the Dana Scholars.

Dana Scholars must meet the following criteria:

- 1. Completion of at least one year at Guilford College with a minimum cumulative average of 3.0 on a 4.0 scale at the end of the spring semester, 1977.
- 2. Qualities of leadership in college and/or community activities demonstrated in such ways as:
- a. Exceptional academic performance
- b. Effective participation in campus government
- c. Effective performance in college committees and organizations
- d. Recognizable influence toward a better college community within various groupings (athletic teams, dormitory groups, organizations, and clubs)
- e. Effective performance in carrying out the responsibilities of an elective office or appointive position, including those for which remuneration has been received.
- f. Effective performance of some community activity.



If I am going to be held responsible for getting labs and papers in on time, I should think that the college would give me credit for being able to get myself into bed on time, that is to say, protect the more inalienable of my rights, such as the privacy of my own room. And if that is not their purpose in developing such regulations, I resent the implication that my private life consists of oray after orgy after orgy. Guilford College is composed of a body of students, not parents or trustees and we would like to see a little more satisfaction on our part about some of the things that are expected of And yes, this great Quaker tradition. Well, get your mind out of the gutter and relieve mine from a myriad of oppressive and silly regulations. I'm in college, and it is really high time that I be allowed to make some of the more important decisions in my life such as when my guests should be leaving or staying!

In addition, all nominees must submit in writing a list of all the special activities and responsibilities they have undertaken during their tenure at Guilford College, as well as community activities they wish considered.

A Dana Scholarship is for one eyar. It may be renewed, however, at the discretion of the Dana Scholarship Committee, provided that the Scholar continues to meet all the criteria and that all of the procedures shown above are followed, including renomination.

Dana Scholars receive grants ranging from \$200 to full tuition, depending on each charged with determining the amount of the grant given to each Scholar.
