

U.S. exploits Somalia

On television we don't see Somalis involved in the government of their country. Instead we see representatives from the US and UN. Boutros Boutros-Ghali, the UN Secretary-General, has proven to protect Western interests in the past as engineer of the Israel-Egypt treaty. Robert Oakley, leader of the U.S. Special Envoy to Somalia, is an expert on the Middle East. He was an ambassador to Somalia during the Ziyad Barre era.

He was also an ambassador to Pakistan who played a leading role in involvement in Afghanistan.

Oakley is depicted as running the country, calling meetings, giving orders without consulting Somali leadership. This practice is justified by conversely depicting the Somali leadership as out-of-control clans who are always fighting each other.

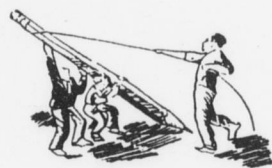
