ABC News reported that in a courtroom, Williams clutched a small teddy bear and wore a brace on her right hand and a bandage on her left ankle.

Carmen Williams told The Charleston Gazette that she has barely left her daughter's side and knows that it will take a long time for her Megan to recover.

"I just want my daughter to be well and recover," said Carmen Williams to ABC News. "I know the Lord can do anything."

"She is not going to forget this," Adams said. "She'll have to learn to trust others again. Her trust was destroyed. She'll have to learn how to trust people again."
