Members are selected on the basis of scholastic standing over the past two years. Only juniors and seniors are eligible for membership, with elections occuring three times during the academic year. Students must have completed 90 or more credit hours with a GPA of 3.5 or more on the total hours attempted, or 75 to 90 credit hours with a GPA of 3.6 or more. Graduating seniors selected in the spring must have a GPA of 3.4 or greater on all hours attempted.

Through Kappa Nu Sigma the college administers the Helen Price Scholarship Fund, from which two scholarships are awarded in the freshman and the sophomore classes respectively. This year Kappa Nu Sigma awarded Lisa Powers, a sophomore and Mari Jon Owens, a freshman, for their achievements. This is the second year that Lisa has received this award.
