number at radio station W8T8 during times of severe storms. [See details later in this issue]. Commissioner Hasulak reminded residents to update their Hurricane re-entry permit at the Town Hall.

As to reinstatement, the employee can look forward to being given a position with the Town. This position may or may not be the same as the position the employee vacated when she went on maternity leave. She will, however, retain her seniority and pay when she returns to work.
