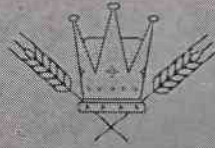

portable household electrical appliances in which the production of heat is the primary consideration. The standards cover methods of testing, performance, duration, safety ratings, nameplate markings and

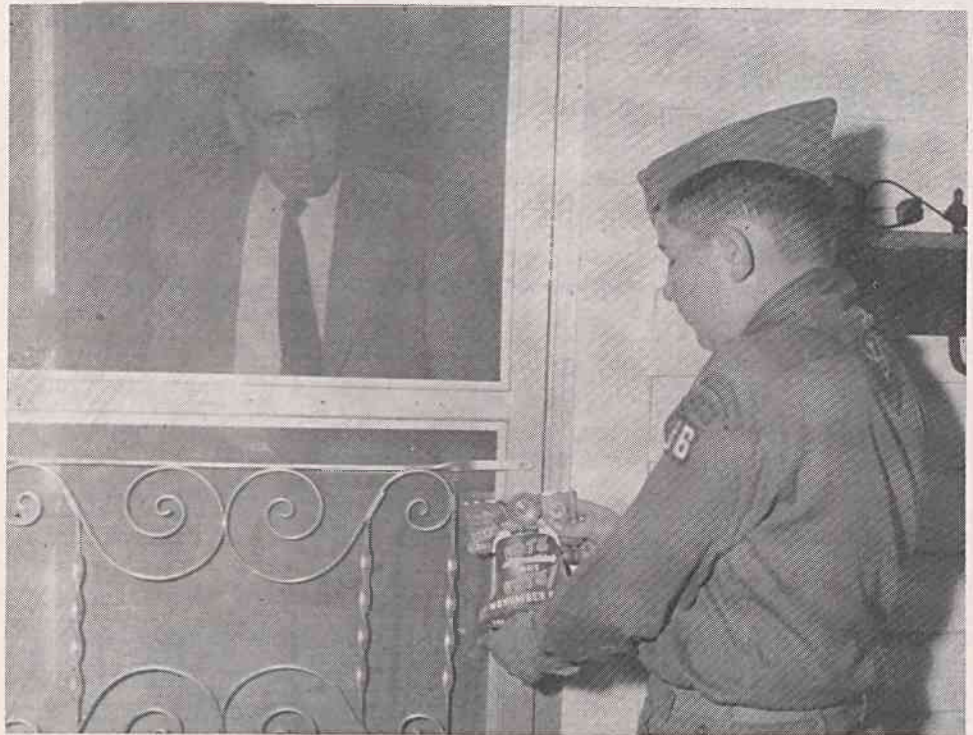
