

## **Blood Donors Are Urgently Needed Dec. 4**

Bloodmobile Coming To Draper; Special Efforts Being Made To Catch Up With Area Quota

The Bloodmobile will be stationed at First Methodist Church in Draper from 11 a. m. until 4:30 p. m. Tuesday, December 4.

Officials of the local blood program are appealing for a large number of donors to make up a deficit in the community's quota.

From July 1, 1962, through October 31, 1962, Tri-City people used 260 pints of blood. During the same period only 213 pints were collected.

Considering the additional blood used in November, the collection of blood in the Tri-Cities is currently approximately 100 pints behind the actual usage by local people.

B. F. Dunton, Bloodmobile chairman,

pointed out that, since the blood program was started in the Tri-Cities in January, 1961, a total of more than 1,300 pints of blood have been used. "Not one penny has been charged for the blood itself," Mr. Dunton said. "A few people still think they pay for the blood they receive. That is not true.

"The charge is made for the administration of the blood. The blood itself is free, but only because our people donate it free of charge.

"We have a good number of volunteers who give freely of their time, and donate blood as often as possible. It is these people who make it possible to keep the blood program in operation.

"Many people who have been helped by the blood program have donated blood or have had someone donate in their name. Unfortunately, however,

### Christmas Pay Will Be Issued Before Holiday

A change in the company's Christmas Pay policy for all of the hourly paid and piecework employees in the North Carolina and Virginia mills was announced in notices posted in the mills last week.

The previous provision for a day's pay on Christmas Day has been replaced with a payment to be made before Christmas. Eligibility requirements also have been revised.

Under the new plan, all employees on the active payroll December 15, who have continuous service beginning before September 16 of this year, will receive straight time pay for eight hours.

This payment will be in addition to their regular pay. It will be paid in a separate check to be distributed with the regular paychecks for the week in which December 15 falls.
