The town meeting was held Monday night, March 5th with only three citizens in attendance. The meeting was called to order by Mayor Jimmie Morris and Howard Tyre opened the meeting with prayer.

The minutes of the last meeting were read and approved. The expense sheet was passed out to the alderman for their approval. After some rather serious discussion of several items on the list of expenditures, the alderman voted to pay the monthly bills.

In other discussion a possibility of having a \$27,000 water softener tank for the water system built locally was discussed and further information would be available at the next meeting. The aldermen accepted a check for \$200 from the Jr. Woman's Club to be used for building a 20ft. bridge to the picnic area in the town park.

The aldermen turned down the opportunity to make a donation to the Arts Council stating that the policy of the town is not to donate to organizations out of tax monies.
