



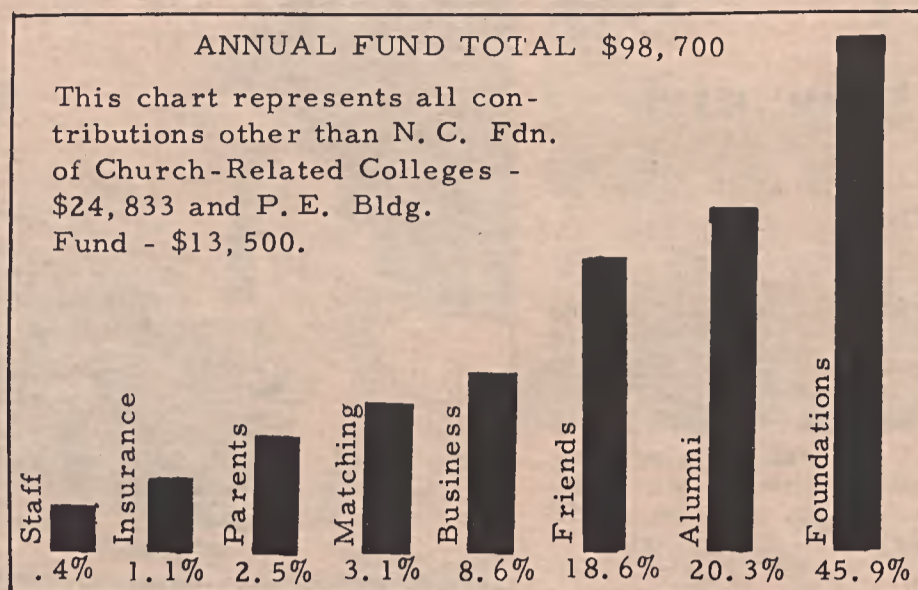
# Belmont Abbey College 1971-72 Annual Report
