#### The Donald Sterling Fiasco: The Real Story

It has been almost a month since Adam Silver; the commissioner of the National Basketball Association (N.B.A), banned Donald Sterling (owner of the LA Clippers) for life from the N.B.A. and recommend to the owners that Sterling be forced to sell his team. Has anything really changed since then?

There's no doubt about it that Sterling's comments were offensive, derogatory and downright degrading. However, does killing the messenger, put a stop to the message or is it simply an attempt to appease those who might be offended?

What is the message? The message is that professional sports are more or less a microcosm of society in general when it comes to racism. For example, when you take a look at the four major sports (football, basketball, baseball and hockey) there is only one majority owner that is African American. Michael Jordan is the owner of the Charlotte Bobcats; his ownership represents 3.33% of all NBA owners.

To put things in proper perspective, there are 32 NFL teams, 30 NBA teams, 30 Major League Baseball teams and 30 National Hockey League teams for a total of 122 teams. In other words, there is only one African American majority owner (which is .81% or less than 1%) out of a possible

It is painstakingly obvious to some and perhaps not to others that the majority of the teams are owned by wealthy white males, especially your football and basketball professional teams (there are 32 professional [continued on page 3]
