

Book Rivals 'Black Boy'

NEW YORK (AP) — The November selection of The Negro Book Club, "Really The Blues" by Mezz Mezzrow and Bernard Wolfe, is called "the damndest book you will ever read." It is the jazz-happy autobiography of a white man who chose to live as a colored man — even marrying a colored girl — and the writing is unusually frank and honest.

The book illuminates the dance floor, the barroom, the jazz scene and so forth, showing the part they have played in American history. Written in rich, racy American idiom, "Really The Blues" should be interesting not only to fond fans of jazz, juke-box fans, and aficionados of toasters and sociologists, but well, it adds a link in the chain of history of the progress of colored people and should evoke as many comments — and possibly controversies — as Richard Wright's "Black Boy."
