

Greatest Show Ring Bull Retires



After dominating the show rings of the nation for the past 12 years as the greatest of show animals, Netherhall Swanky Dan, the national grand champion Yorkshire bull, is retiring.

This announcement was made by Otto Schering, president of the Curtiss Candy Company, which operates the farms at Cary, Ill., where Swanky Dan will continue to serve as their famed Yorkshire herd sire.

His latest triumph--senior and grand champion at the National Dairy Cattle Congress at Waterloo, Iowa--represented the 84th consecutive championship of his career, achieving the record of winning more championships than any other dairy or beef animal. He has become both a legend and an institution throughout the agricultural world. Swanky Dan qualifies as the "grand old man" of any group of champions. His 13 years of age are equivalent to 75 years in a human. He continued his winning ways at an age twice that of most prize show cattle.

His greatness is also supported by the winnings of his progeny. At the Dairy Congress, he was sire of the first prize get-of-sire, as well as sire of heifers that won the junior and reserve junior championships. His get stand high in production. His first daughter to finish her production record at the Curtiss Farms gave 19,000 pounds of milk and 666 pounds of butterfat.

"All good things must come to an end and so has Swanky Dan's show ring career," Mr. Schering commented. "He could go on winning for some time yet, but it is more appropriate that he quit as a undefeated champion."

ADVISORY COLUMN

L.C.M. — My husband is in a sanatorium and I must make my own way. I do day work and since it is not regular, I have gotten in debt and am in dire need of all the time. I know I must not give up but being broke is getting me down. Never in my life has my financial status been at such a low ebb.

Ans: Find a regular job. You can't get out of debt or make ends meet if you do not have a steady income. When there is a definite amount of money coming in each week, you can plan your living expenses accordingly. A full time job will get you straightened out financially in a short time.

F.B.R. — I stored my furniture three years ago when I left Chicago to come here to the winter. I have made nice friends, have a good job and I intend to stay. I see that I made a mistake not disposing of my furniture yet. I hesitate just to stop the storage payments. What should I do?

Ans: Sell your furnishings if you don't value them enough to have them moved. It would really pay you to make the trip back home and attend to this matter. And -- you might proposition your sister to take these household effects off your hands, since she's getting married Christmas.

D.C. — I went with a fellow two years. We were engaged for one year. Without any warning, he jumped up and married another girl. It hurt my heart as he never came back to tell me why. Now they are separated. He is acting like he wants to go with me again. Should I take him back?

REAL ESTATE MEN OPPOSE FEDERAL HOUSING BILLS

Everything was the rule of the day of the National Association of Real Estate Boards at the Commodore hotel here last week.

In resolutions which no floor debate was allowed, the realtors voted against all types of federal controls in housing. They also demanded the end of low cost government housing and rent controls.

This attack was launched against 700,000 residential units of the Public Housing administration, including nearly 400,000 temporary war line units. The association state ment declared:

"Housing is the responsibility of private industry. The many evils in public housing in this country proved that federally subsidized public housing constitutes a competitive threat to our competitive enterprise system."

Congress, the association contended, should pass a law calling for the end of all government connections with public housing and the destruction of temporary units as fast as such housing can be vacated by the present tenants but in any event not later than 1950.

In its attack on government control over housing such as rent controls and building controls, the association was uncompromising.

USDA TO LIST WAYS TO CUT FOOD COSTS

Want to hold down your food costs? And still eat well? Still feed the members of your family all the vitamins they need? With plenty of variety and the best quality? There is one way to do all of this, along with having a steak once-in-a-while. It's done by "selective buying of plentiful foods."

Selective buying means to look for the abundant and low priced vegetable instead of the high priced vegetable. Or grade B eggs instead of grade A especially for cooking. Or poultry and fish, and fruits and vegetables in season. It also means to shop for processed and canned foods which happen to be abundant. All these kinds of foods are usually more reasonable in price than the foods which are not in plentiful supply.

Each month the U. S. Department of Agriculture says which of the fresh foods are reasonably abundant and which of the processed and canned foods are more than ample to satisfy normal demands. The Department designates these foods in a list of Plentiful Foods.

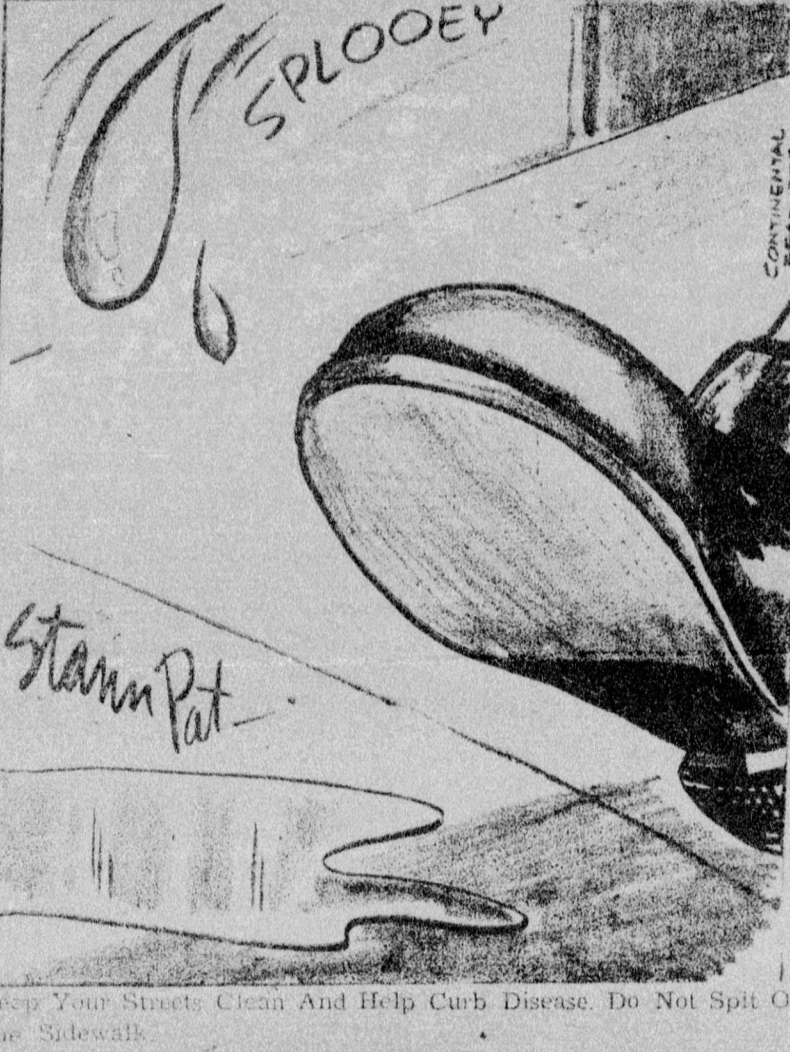
To qualify for the listing every food must be (1) in plentiful supply, (2) commonly used by most people, and (3) generally available in retail stores. This list is made available to radio, newspaper and interested organizations in order to inform consumers about plentiful foods.

The Department estimates that the same quantity of food in a basket of plentiful foods will cost considerably less than a basket of alternative foods which are not plentiful. And the basket of plentiful foods will match the nutritional value of the other.

The aim of this program is to move into consumption the country's abundant food production. That avoids waste. But at the same time, the program stresses that consumers will save their food money by shopping for the plentiful.

So watch your buying and look for the "best buys" every week in the plentiful foods at your grocery store.
