BEREAN SCHOOL EXPECTS RECORD IN ENROLLMENT

The Berean School of Philadelphia after having graduated the largest class in its history, announced this week that this year's enrollment would be a record breaking one. Students have so far enrolled from twenty-one states and one foreign country. Louis B. Yelton, the principal, in describing the courses offered at the fifty year old institution, said that new courses in dressmaking and design would be presented this year. One of the interesting facts in this connection is that many men have enrolled in the crossstitching courses. She also announced that the school is planning to inaugurate evening classes in arts and crafts which will be extended free to members of the community. The Berean School division of commerce released records this week indicating that eighty-nine per cent of the 1949 class is now employed in lucrative positions. The division of men's tailoring indicates that many of its graduates have gone into businesses of their own since June of this year. The activities program will be increased for the school year '49-50 to encourage a larger number of students than heretofore. The school's two choirs and the Theatre Guild will be enlarged as will the athletic program.
