In charging that Rev. Jackson is not eligible for a fifth consecutive term, the petitioners cited Article IV, Section 2, of the Convention's constitution which reads: "A president of this Convention shall not be eligible for re-election after he has served four consecutive terms, until at least one year has elapsed.


