Negro Crime - What Now?

Played up in a full-page box on page 16 of TIME magazine for April 21, is an article entitled: "The Negro Crime Rate: A Failure in Integration." If ever a journalistic report is read critically, this one should be. It is a subtle piece of propaganda that on the surface gives the impression that the editors are "putting in a plug" for integration of the Negro into A-

But throughout this report are many subtle innuendos that can easly provide amunition for segregationists who want to blast away at all sincere efforts to implement the Supreme Court's decision of May 17, 1954.

In summary form the TIME's article reports that "in 1.551 U. S. cities, according to the FBI tally for 1956, Negroes making up 10 per cent of the U. S. Population, accounted for about 30 per cent of all arrests, and 60 per cent of the arrests for crimes involving violence or threat of bodily harm-murder, non-negligent manslaughter, rape, robbery and aggravated assault. In one city after another, the figureswhere they are not hidden or suppressed by politicians-reveal a shocking pattern. Items: "NEW YORK (14% Negro). Of the prison-

ers confined in houses of detention last year to wait court disposition of their cases, 44% of the males and 65% of the females were Ne-

"CHICAGO (15% Negro). In 1956 twice as many Negroes as whites-1,366 to 679were arrested on charges of murder, non-negligent manslaughter, rape and robbery.

"DETROIT (25% Negro). Two out of three prisoners held in Wayne County jail are Negroes. Last month 62% of the defendants presented for trial in Recorder's Court were Negroes. Of last year's 25,216 arrests for homicide, rape, aggravated assault, robbery, burglary, larceny, traffic cases, Negroes accounted

"LOS ANGELES (13% Negro). In 1956 Negroes accounted for 28% of all arrests, and 48% of the arrests were for homicide, rape, aggravated assault, robbery, burglary, and auto

enterprising, and the facts coming from its files must be considered accurate. It is regrettable, however, that Negro crime is widespread, and we are urging the proper police agencies to deal with the problem in a stern manner-both preventitive and rehibili-

The article also said. "Negro leadership could make a start toward lowering Negro crime rates by abandoning the conspiracy of concealment and urging full disclosure of the

To charge Negro leaders with "conspiracy" is a serious indictment. The CAROLINIAN knows that here in Raleigh there is no "conspiracy" to conceal Negro crime. Fact of the matter, the stinging criticism of the Negro press is that it plays up too glaringly "Negro crime", resulting from the profit motive to increase circulation. The question frequently put to this newspaper is: "Why do you publish so much crime?"

In conclusion the TIME's report asserts that "Negro crime is basically a symptom of a failure in integration" and urged us to "start attacking discrimination in the North with the same fevor that they (Negroes) show in arguing for civil rights in the South."

The idea, that an all-out fight against discrimination and the implementation of integration will in the long run be constructive forces in reducing the crime rate among Negroes, is a happy thought. And if integration will be a leavening force that will make the United States society accept the Negro on his human merit, we certainly are for this solution one hundred per cent. For this happy thought, we can say to TIME magazine: "We agree with

Negroes Below Whites

In several of the daily newspapers, we read of a psychology professor at Randolph-Macon Woman's College in Lynchburg, Virginia, who has written a book, The Testing of Negro Intelligence. The book concludes that the intelligence of Negroes in the United States is consistently lower than that of whites.

The author of the book is Dr. Audrey M. Shuey, who is chairman of the psychology department of Randolph-Macon Woman's Col-

The Associated Press review of the book said that the author found that "Negroes have averaged consistently below whites on the intelligence tests and the results point to some native differences between Negroes and whites as determined by the intelligence tests." There has been a "remarkable consistency"

in the tests results, Dr. Shuey said, regardless of whether they pertained to school or preschool children, to high school or college students, to the draftees in World War I and World War II, to the gifted or the mentally deficient, the delinquent or the criminal.

The book by Dr. Shuey contains a foreword by Dr. Henry E. Garrett, professor emeritus of psychology at Columbia University and visiting professor this spring at the University of Virginia.

According to Dr. Garrett, the volume by Dr. Shuey is "a legitimate scientific enter-

"I welcome every honest effort to aid Negroes in improving their status as American citizens, but I do not believe that it is necessary to 'prove' that no racial difference exists, nor to conceal and gloss over them, if found, in order to justify a fair policy toward Negroes," Dr. Garrett wrote in the foreword. In this book, Dr. Shuey, a graduate of Columbia University said its conclusions are based upon more than 288 intelligence tests given to white and Negro children and adults over the last 40 years "by many sociologists and psychologists."

We have some doubt as to the reliability of these tests results in helping a researcher to reach conclusions regarding the intelligence deficiency of Negroes as compared to whites. Certainly, 288 subjects are not enough to draw conclusions regarding the intelligence of approximately 17 million black citizens. We would have more faith in the study if it included, let us say, 2,000,000 Negroes.

In the newspaper report, Dr. Shuey is credited with saying, "The scientists who gave the tests themselves recognized that environment and stimulation influenced scores on the tests."

From our knowledge of intelligence tests, race is not a reliable basis for study. The two factors that really count are: mental capacity or potential, and environmental stimula-

We do know this, however, that Negroes in many areas have not been exposed to as many cultural influences as whites in their same age group. For example, a black child in the Mississippi Delta very seldom leaves his immediate residence. Certainly he does not get to travel, to see operas and stage plays, to visit libraries and museums, and so on. These environmental deficiencies will, in a large way, influence intelligence tests results.

It is regrettable that many people will not read this book critically. Already a number of Southern school officials are saying that desegregation of schools should be delayed because Negro students are intellectually and academically inferior to whites in all grade levels. The findings in this book will only give them arguments for confirming their beliefs.

We Need A Negro Congressman

The time is "ripe" for a Negro Congressman from Wake County to take a reat in the North Carolina General Assembly when the elections are run off in May. The Negroes of Raleigh and Wake County now have opportunity to make this possible.

The candidate this year for one of the three seats from Wake County is Nelson H. Harris of Shaw University. The Congressional district in which Wake County is located is a "natural" for the election of the first Negro Congressman since the period of Fusion politics, 1890

There will be, without doubt, white men who will aspire to fill these seats. The announcements of their intentions have already


been published in our daily newspapers. Certainly, we can "pick no quarrel" with them.

Since Negroes constitute about one-third of the population in Wake County and Raleigh, we believe we have white friends who will help us in our campaign to elect Nelson

LITTLE ROCK BOY MAY NOT MARCH WITH CLASS

One of the eight remaining Negro students in the Central High School at Little Rock, Arkansas, is due to be graduating quite soon. Graduation day is one of the happiest days in their

For this boy, the chances are that he will remember his graduation with mixed emotions. News emanating from Little Rock indicates that segregationists are planning to keep this lad from marching with the graduating class. He has already been barred from the normal activities which precede gradua-

To such depths is it possible for adults in a civilized community to descend to wreak their vengeance on a helpless lad?

The Little Rock incident illusfrates as nothing else can what happens when one temporizes with the forces of evil. Had President Eisenhower made it nlain to the Governor of Arkansas, when the latter visited him, that he expected him to obey the law and see to it, as Governor that the law was enforced in Arkansas, there would have been much less trouble.

The federalized National Guard, composed of white Arkansens who are in sympathy with the rebellion, and the school authorities have been derelict in the performance of their duties. There yet remains time for the Administration to

see to it that the Court order is compiled with in letter and spirit. - THE SHREVEPORT

IT MUST BE DONE

Deep South states, in their frantic, desperate effort to block desegregation of the schools, have, since May 17. '54, poured more than \$2,000,000 into their efforts to circumvent, or negate. the United States Supreme Court decision of that date, that outlawed segregation in the public schools.

Virginia, usually unimpeachable sources report, has spent \$508,000 in its "massive resistance" program-generally conceded to be a falling effort, but being doggedly continued. Georgia has poured away nearly \$500,000. Alabama, in a campaign of vote denial, intimidation, oppression, and economic pressure has expended a half million.

The money and support come from the taxpavers themselves. unsuspecting though they may be, from wealth racist segregationists from White Citizens councils, and other hate groups, that, in their delaying action campaign, are counting heavily on the incapacity, or inadequacy, of Negroes and integrationists to wage long drawn out fights in the courts and on legislative fronts.

The segregationists' strategy is simply to outlast those fighting for equality and democracy; to beat them down with more casily available and superior resources, the forcers of hate control because they are in power. a power that, along with segregation, they are struggling furiously to hold.

segregationists, although they know the law is against them, reason that the least they will be able to do is force Negroes to accept "voluntary segregation"-to "choose" and ask for Jim Crow schools

Does the fight, then, resolve itself to which side 'can last' the longer That, unquestionably, is an important factor.

And that poses a challenge to those seeking simply justice, equality, constitutional government and inherent rights which

they never should have been de-

The challenge must be met

squarely, and with full knowledge of its terrific impact. It must be met courageously with a readines to sacrifice for vic-

Those who would be first class citizens must now, as never before, resolve to take not a single backward step. They must give money, much money, to continue to meet the opponent on equal footing, in court litigation and its ramifications. They must meet the continued, and the new as saults that are still to come. It is not easy, it will not be easy, but it can be, it must be

Citizens of North Carolina are heartened by the dispatch and determination with which Old North State courts are handling cases involving klan attempts at violence and group intimidation. Within a week after Judge Williams had sentenced the itinerant Reverend James (Catfish) Cole of Marion, S. C., and one companion, for inciting to rist in the Lumberton klan-Lumboe Indian fraces, we read that sunilar summary justice has been dispensed by Judge Zeb Nettles of Mecklenburg County.

There Lester Caldwell and two companies were sentenced on March 20 to severe prison terms for attempted dynamiting of a Negro school. Whether these same klavern habitaes were also responsible for the dynamiting of Jewish synagogues in Gastimla and Macklenburg counties was not established by the

That such outbursts of victous prejudice will not quickly find By holding on long enough, repetition seems assured now that Governor Luther Hodges' warning of January has been implemented by the courts. If the governors and the judi-

ciary of some neighboring states could be prevailed upon to show like decisiveness in upholding the civil peace and the laws of the land, the lunatic fringe which still holds with violence and vigilanteeism would itself be intimidated into compliance. THE SOUTH'S MILITANT

MINORITY The way the South has refused to be stampeded into violence by a few extremists anti-Negro newspapers has been astonishing. The constant harping on the possibilities of violence has been a suggestion to vio-

But in spite of this indirect incitement to violence, the South for the most part has remained calm in a way that gives ultimate hope of an amicable settlement of the complex questions that currently vex us. There is a core of democracy at the heart of the South and down deep in its heart there is the desire for justice for all men: It is safe to say that at heart the majority of the white South is willing to take the high road of Christianity and democracy. They have not only counted the cost of obeying the mandates of the Supreme Court; but they have counted the cost of not obeying. They know full well that when law and order give away to passion and prejudice, that the country is riding

They know too well what an advantage it gives Russia to point out our internal dissension over a matter of law that runs counter to race prejudice. When a supposed Christian nation renounces the Christian ethic and when a supposedly demorracy breaks with the democratic tradition. Russia riots with prospects of an early conquest of the world.

In fact when a democracy becomes undemocratic and when Christianity becomes un-Christian we are playing Moscow's game for her, for we are in very truth giving comfort to the one-

So to its credit it roust be said that the South his maintained a surprising composure, in the face of constant prodding by some of its newspapers to resort more and more to violence. These newspapers indirectly suggest violence by pretending Should there be bloody out-

breaks here and there, before current vexing matters are amicably settled, the blood of the slain will be upon the newspapers which are in subtle ways trying to cultivate violence. The trouble in Little Rock is purely of the cultivated kind Had there been a courageous

governor in the capitol instead of a third-rate politician, the national blot that is Little Rock, would never have happened. Yet politics is taking precedence of principle in far too

many instances. In fact, it is difficult to see the heart of the better South through the maze of political intricacles and machinations and aspirations. This writer is convinced that at heart the majori-

ty of the South is right. But the South's current militant minority has taken over. We often refer to the communism of Russia as emanating from the few who held the mase ses in virtual bondage. It is not different here in the South where the militant minority has taken over and dictating sub-

mission of the majority. The South's refusal to accept the Ku Klux Kaln and its manner of handling the situation speaks volumes of the spirit of the better South. The readiness with which the Klan is denounced is heartening.

The real trouble in the South today is the politician. As long as the color question can be manipulated to get elected to office we may be assured there are those ready for such manipulation. What the majority of the South is at heart cannot at present be known. The militant

minority is in the saddle. The hope is that they may run their course without destroying the South and the nation. Of this there is great danger.

There is the lively hope that the better South may rise up and rescue itself from the milltent minority that will stop at nothing-even violence-if political advantage is to be had. It is good and encouraging for

Negroes to know that the outward and rampant attempts of the South's militant minority to stampede the South into vio-Ience do not stem from the majority of the white South but from its loud-mouthed politicians As the fabled man told his son

as the latter was leaving to make his fortune in the world: "Son, go out into the world and make money honestly; but if you cannot make money honestly, make money".

The Southern politicians are out to be elected; and if such election comes at the expense of Christian race relations, it matters little to them. The main thing is getting elected.
