## Public May View Display Home In Sandy Land Village Starting Friday

The fabulous Display Home, located in Sandy Land Village, near Jeffreys Creek School, will be open to the public beginning Friday, July 4, at 10 a. m. The doors to the model home will stay open on Friday until 9 p. m.

Edward H. Chavis, owner and developer of the 23 acres on which the first model home has been built plans to build other residences on the site on the same plan or a plan to suit the owner.

The home now located on the Chavis property consists of 3 bedrooms, a living room, kitchen and bath. It has its own well, copper plumbing and ceramic tile. The home is located on property 100 by 150 feet. The other homes to be constructed on the land will have similar lots.

Carter's Inc. furnished the structure and blinds were supplied by Matthews Shade Company, both of this city. A spokesman for Chavis said that the Display Home will be open to the public for two weeks, starting Friday. On weekends the hours will be from 9 a. m. until 9 p. m., and during weekdays the home may be seen from 9 a. m. until 5 p. m.

Conventional loans with low down payments can be arranged for a home on the land. Directions for getting to the Display Home follow: Proceed out highway 70 from Glenwood Ave. across the Crabtree Creek Bridge, turn onto highway 50 leading to Creedmoor, drive past the Jeffreys

Crabtree School, located on the left about five miles north on highway 50, proceed to People's Store, turn left and at the end of the road turn right and travel one half mile up the road. Signs will direct you to the Display Home after you

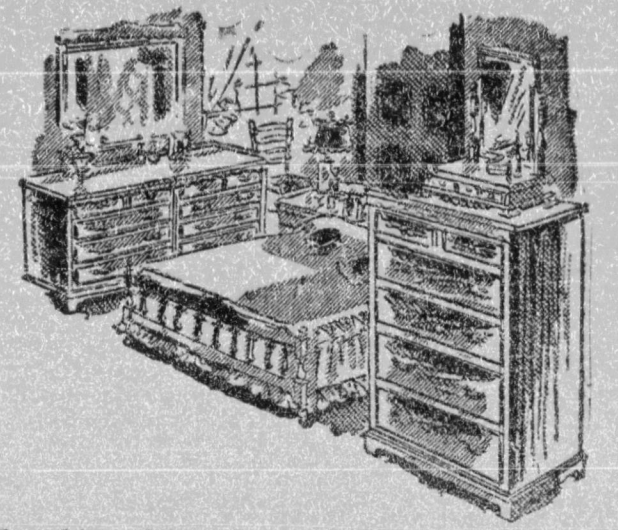

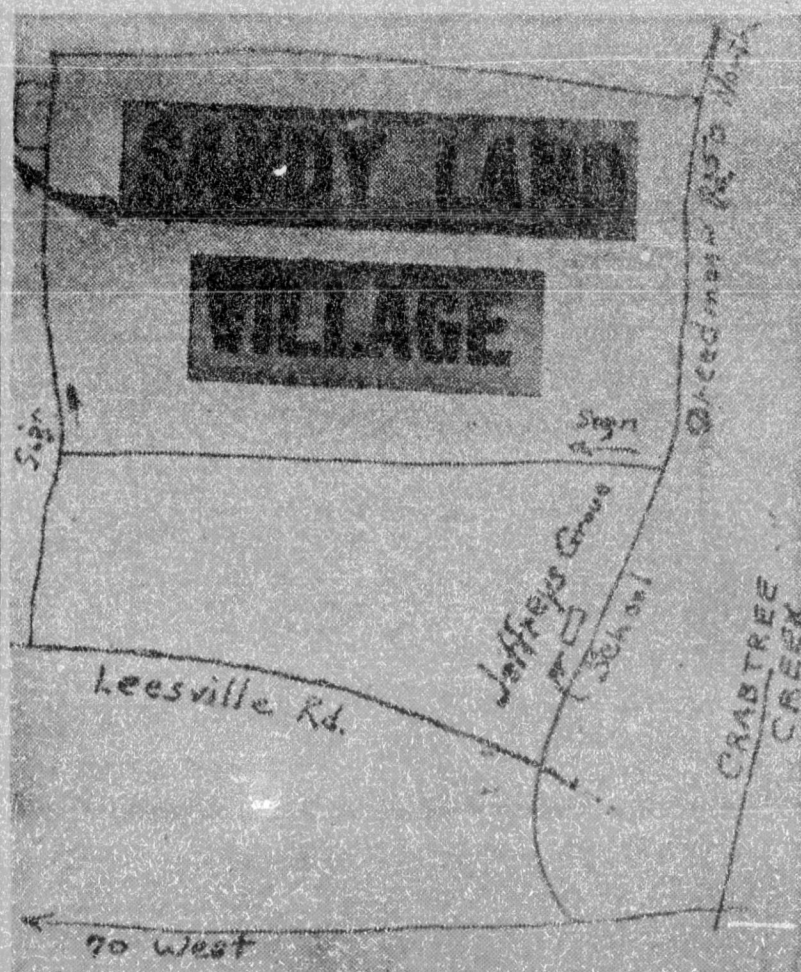
