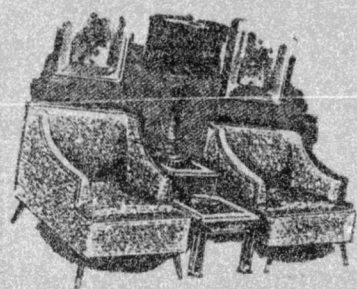

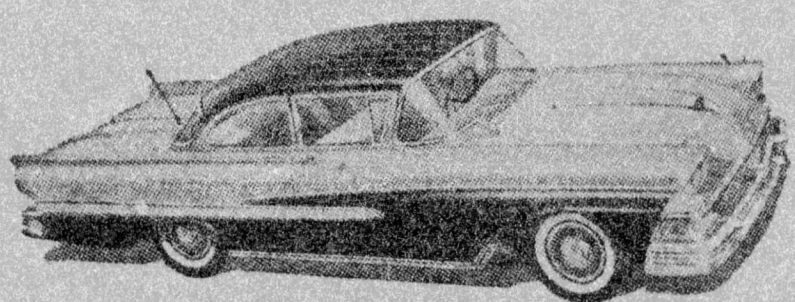

WENELE. — For the first time in the history of Wake County, five mothers, all widows with a total age span of 401 years, were honored with special festivities at Mrs. Ruth Morgan's home near here on Thursday afternoon, July 31.  
The party featured as the chief guest, Mrs. Rosa Perry, 67, the youngest, and a visitor from a northern state.  
Other honorees were: Mrs. Ellen Todd, 91; Mrs. India Strickland, 86; Mrs. Guion Perry, 83; and Mrs. Lizzie Burns, 74.  
The majority of these mothers have lived in Wake County an average of 25 to 30 years.  
The menu served the mothers included: corn, whole wheat, and white breads; fried chicken, stew and chicken salad, meat loaf, green butter beans, corn, tomatoes, lemon chiffon cake, ice cream and jelly.  
Each mother attending the affair was given a souvenir fan.  
Salvos were rendered by Mrs. O. M. Webb, Mrs. Wayman Morgan, and Mrs. Geneva Kattman. Pianist was Mrs. John D. Robbitt.  
Mrs. Ellen Todd, 91, has 13 children and 38 grandchildren. Six of her children are dead.  
Mrs. India Strickland, 86, is the mother of eight children and has 16 grandchildren. Two of her children are dead.  
Mrs. Guion Perry, 83, is the mother of five children and has 15 grandchildren and 20 great grandchildren.  
Mrs. Lizzie Burns, 74, is the mother of nine children. She has 3 grandchildren and 2 great grandchildren. Five of her children are dead, and  
Mrs. Rosa Perry, 67, has 16 children and 25 grandchildren. Four of her children are dead.
