**Horner Hears Varied Docket In Court Here**

Judge Fentress Horner of Elizabeth City, presiding in Chowan County District Court, Tuesday disposed of a number of cases called by Solicitor Wilton Walker.

Probable cause was found in the case where Dewey Williams was charged with second offense of taking indecent liberties with a minor. The case was sent to Superior Court and bond was set at \$2,000. Alphonso Henry Dail took an appeal after he was fined \$50 and taxed

costs of court for failing to have liability insurance. He was also ordered to pay a fine of \$10 and costs or serve 10 days in jail for contempt of court after failing to appear earlier. His appeal bond was set at \$100.

Also taking an appeal was Charlie Wayne Hughes, charged with driving drunk. He was sentenced to 90 days, suspended upon payment of \$100 fine and costs. His appeal bond was set at \$200.

Roy Rogers Brooks, convicted of bastardy, was sentenced to six months.

Marvin Earl Bond, charged with third offense of driving without a valid operator's license, was sentenced to 30 days.

Other action taken included:

Alvin Alexander, failure to comply with a former order, pay arrears and costs.

Russell Paige, failure to comply with a former order, 12 months, suspended upon payment of \$100.25 and costs.

James C. Bond, non-support of an illegitimate child, \$10 per week and costs.

John William Johnson, non-support, 12 months, suspended upon payment of \$30 per month and costs.

Fred Rountree, failure to comply with a former order, pay arrears and costs.

Ashley Mark Page, Jr., speeding, prayer for judgment continued upon payment of costs. He was ordered not to drive except as transportation to and from school.

Milton Elliott, failure to comply with a former order, pay arrears and costs.

Robert Graham Nixon, no operator's license, prayer for judgment continued.

Embery William Perry, speeding, prayer for judgment continued.

Mathew Madrey, driving drunk and without an operator's license, six months, suspended upon payment of \$150 fine and costs.

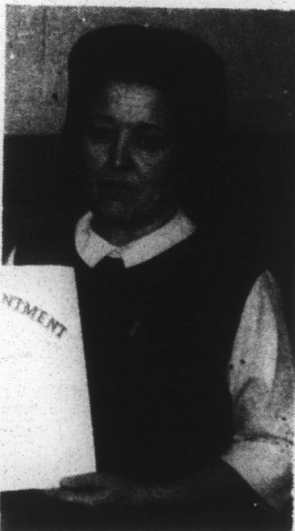
Freddy Lee Brown, petty larceny, six months.

Wallace White, failure to comply with a former order, pay arrears and costs.
