Our country should determine for itself whether American jobs are endangered and whether damage is being done to our textile and apparel industries. Under the circumstances, it seems to me that the best means of achieving a solution to this problem is to use the Trade Act, HR 14870, as the vehicle for establishing a textile apparel orderly marketing system. The House Ways and Means Committee will be considering this measure soon, and if our negotiators have made no further progress with the Japanese by early May, I am hopeful

that the committee will report out a bill setting import quotas on textile products.


