

### Kids' Education Rights

(Editor's Note: The twentieth article in a series published monthly, about children, by the Human Development Division of the Pamphlet - Pamphlets - Camden-Chowan District Health Department.)

**EDUCATION RIGHTS**  
Due to the passage of a number of laws in recent years parents now have many well defined rights influencing how their children are educated by the public schools. Specific procedures have been established requiring the parents' written agreement to any special education program provided for their child, and requiring the public schools to provide an appropriate program for every child.

One of these many procedures is the right to a formal hearing. If the parents want some change made in their child's educational program, and the schools do not make these changes to the parent's satisfaction, then the parents may request such a hearing to override the school's decision.

Also, if schools feel a child needs a special service and the parents refuse that service, then the schools may request a hearing to override the parents' decision. Both types of hearings have been held in the Albemarle area.

Some parent rights specified by these laws are as follows:

Parents have a right to a hearing upon written request. They have a right to legal counsel, to examine all school records relating to their child, to present evidence, to subpoena witnesses, and to cross examine witnesses called by the school.

The hearing must be conducted at school expense, a written transcript must be made of the proceedings and final decision, and the parents must receive a copy.

The hearing must be held and a decision reached

within 45 days after the parent's request.

An impartial hearing officer must be chosen who is not employed by the schools and whose personal or professional interest does not conflict with his/her objectivity.

The hearing officer's decision is final unless appealed within 30 days. Either the parents or school may appeal to the state level for impartial review of the hearing and decision. If still not satisfied, the parents or school may then take the matter into court.

Any school system which does not follow the above procedures is subject to lawsuit by the parents.
