SUBJECT MATTER: Subchapter 15 NCAC 7L sets the criteria for awarding grants to local governments for coastal planning and management activities. The grant criteria are reviewed annually against the goals of the state and federal coastal programs. This year the principal change is to reduce the levels of funding to local governments due to decreases in federal grants.
