
VRCD To Release State Algal Index day and the current day and predict the condition for the next

three to four days "This index will be sort of like a weather report," said Grimsley. "We won't always be right, but we expect to be pretty accurate since it will be based on some highly technical information compiled by our people in the Division of Environmental Management."
The Division of Environmental

Management will also send out a monthly graph of the algal index to show trends in the condition of

The daily index and the monthly trend report will be made available to news media throughout the Chowan River Basin. Graphics suitable for newspaper publication and television presentation will also be made available.

Grimsley said, "We hope the algal index has a very short life.



We intend to clean up the river and eliminate the need for the index, but we want to provide this service to citizens and visitors in the area while we are still working on the overall algal problem."

In determining the algal index, Dr. Bob Holman, the emvironmental scientist who heads the Chowan River Study Group in the Division of Environmental Management, will take into consideration such factors as chlorophyll present, water temperature, number of bloom species present in samples, weather conditions and other factors. In addition, six volunteer "river watchers" will provide Holman with daily information based on their observations of the

Here is a list of the algal index ranges and what they indicate:

Zero to two: River clear. Conditions varying from no nuisance bloom algae present to small populations present in the water column. Conditions favorable for all recreational and commercial activities.

Three to four: Nuisance bloom algae are present at low to medium population levels. Some may be visible to the naked eye. Recreational and commercial activities are not significantly affected.

Five to six: Populations of nuisance bloom algae reach a level at which filaments or balls of algea are visible, and there are possibly some small, widely scattered surface streads of algae. The color and presence of the bloom streaks are unpleasant to swimmers and boaters, but there should be no significant affects on recreational or commercial fishing.

Seven to eight: Surface mats of nuisance algae are scattered and may be somewhat heavy in localized areas if the wind is calm. Streaks of algae are prevalent. Swimming and boating are adversely affected. There are odor problems and some impairment of commercial and recreational fishing.

Nine to 10: Large portions of the lower Chowan are covered by extensive surface muts of the nuisance bloom algae. Windy conditions may temporarily eliminate mats, but they will quickly redevelop as winds calm. All activities are significantly affected, and there are odor problems in localized areas. Adult and juvenile fish populations are heavily stressed, and fish kills are possible.

The algal index will be offered throughout the summer until mid-October, when the likelihood of a significant algal bloom is romote.

Tax Exemption For Singles

GREENSBORO - Single persons earning less than \$3,300 in 1982 may be exempt from Federal income tax withholding, the Internal Revenue Service said today. Many North Carolina students with summer or part-time employment fall into this category.

There are two requirements for the exemption from income tax withholding. First, there must not have been a tax liability for the taxpayer in 1981. Second, there should be no expected tax liability for 1982. Generally, anyone earning less than \$200 per week may be exempt from withholding. Students who have over \$1,000 in unearned income, such as interest,

dividends, or trust fund income, and who are claimed as dependents on their parents' tax return, are not exempt from tax withholding on earnings, even though their total income is under \$3,300.

A person qualifying for withholding exemption ould file a W-4 Form with their employer and com-plete block "6". Even if a person is exempt from in-come tax withholding, they are still subject to Social Security tax withholding.
