At the above mentioned time and place the above owners shall be entitled to be heard in person or by counsel upon all legal or factual questions relating to said matter and shall be entitled to offer such evidence as he or she may desire which is relevant or material to the questions sought to be determined or the remedies sought to be effected.

YOU ARE FURTHER NOTIFIED that if, upon such hearing, the Building Inspector shall find that the above described building is uninhabited or abandoned for use and is in such a dilapidated or sub-standard state of disrepair as to constitute a fire or safety hazard or to be dangerous to life, health or other property, or is a public nuisance, the Building Inspector will make an order in writing directing to the owner of such building, requiring the owner to remedy such condition so found to exist by demolishing and removing said building or taking such other steps as may be necessary to abate the nuisance and remove the hazards within a period of not less than sixty (60) days as may be prescribed by the Building Inspector and the Building Inspector may make such other orders and take such other procedures as are authorized under the above mentioned ordinances enacted by the Council of the Town of Edenton, North Carolina.
