Elton Edwards' bill," Green Sen. Elton Edwards said

that there were few things as important as protecting our children from those who would, for their own gain or satisfaction, abuse them or se them for immoral or improper purposes. 'I have been much concerned about this problem, and feel that its an urgent necessity that we deal with it now and in a way that will provide a meaningful deterrent to abusing our children in this way," Edwards stated.

Edwards' bill, which is divided into five sections, would make sexual abuse a Class I felony, and suggests psychiatric counselling for both defendant and victim. Promoting child prostitution would be a Class G felony, while child prostitution itself would merely be a misde-meanor. The bill recommends counselling for the children involved, and the sealing of their arrest and guilt records The child's records may be tions occurred within two

Child pornography would also be a Class G felony, as would the encouragement of a sexual performance by a child. Mistake of age is considered to be no defense in any of these offenses, under this bill.

The section on child pornography is similar to a bill introduced by Senator Robert Warren of Benson as a result of the Legislative Research Commission's recent study of the Obscenity Laws.


