EDENTON - Edward Nelson "Pete" Manning, 89, of 216 West Eden Street, passed away on Thursday, February 21, 2019 in his home.

Manning was Mr. born in Cumberland County on November 8, 1929, and was the son of the late James C. and Eva Averitt Manning. He had retired from The Chowan Herald after more than 50 years of employment. During his tenure as linotype operator, general manager, and publisher, he



experienced changes from hand-set type, hot-lead linotype slugs, perforated tape-driven typesetters to computer newspaper page pagination, and from hand-fed newspaper presses to high-speed automatic rotary offset presses. Other employment was his serving as a licensed North Carolina Funeral Director while being a part-owner of the former Swindell-Bass Funeral Home.

Active in local and state affairs, he had served on the Edenton Town Council, as President of the Edenton-Chowan Chamber of Commerce, Chairman of the Chowan County Board of Elections, trustee for Chowan College, and as a member of the Board of Directors for The Biblical Recorder. He was a charter member of the A.J. Fletcher Communications Center of the Baptist State Convention, had been appointed by Governor James B. Hunt, Jr. to the Edenton Historical Commission, and had served as both Vice-Chairman and Chairman of the Chowan Hospital Board of Trustees.

As a member of Edenton Baptist Church, he served as a member of the Deacon Body for 50 years, serving many terms as Chairman. He was Chairman of the Building and Grounds Committee for more than 25 years, Director of the Children's Sunday School Department for 32 years, Chairman of the Personnel Committee for several years, and had served as Chairman of two Pastor Search Committees.

In addition to his parents, he was preceded in death by his wife of nearly 65 years, Betty Letcher Manning; and by his brother, James Thomas Manning.

Surviving are two daughters, Nelle Manning Hyatt and husband, The Rev. James Hyatt, Jr., of Franklin, VA, and Anna Kay Manning Laughton and husband, J. Craig Laughton, of Edenton; three grandchildren, James Henry "Buddy" Hyatt, III (Nikki) of Greenville, Clay Hyatt (Jessica Story) of Franklin, and Carole Laughton Sykes (Scotty) of Edenton; and his first great-grandchild due to be born in March.

ORTANT DELINQUENT

Any accounts that remain delinquent will soon see any of the following enforced collection actions occur:

WAGE GARNISHMENT

This collection remedy allows your employer to garnish 10% of your gross wages from each pay period to send to our office until payment of your delinquent bill in full. Our office charges an additional \$60 Garnishment fee to your account for this enforcement action.

BANK ATTACHMENT

This collection remedy allows your bank to freeze any assets you have and send to our office all at once to fulfill your delinquent amount due. Our office charges an additional \$60 Garnishment fee to your account for this enforcement action. Most banks charge the account holder a fee between \$150-\$250 for this action.

ADVERTISEMENT IN THE LOCAL NEWSPAPER

Tax liens that remain delinquent as of March 26th will be advertised in the Chowan Herald on April 3rd and have an advertisement fee added to their account.

FORECLOSURE

This action is the last resort to all other enforced collections actions.

To avoid any of these actions from occurring, call our office as soon as possible to inquire about payment plan options!

IMPORTANT TAX LISTING INFORMAT

Tax Listing forms for both Businesses and Individual Personal Property were due back to our office by January 31, 2019 to avoid the 10% late listing penalty. If you have yet to return your listing form to us and have received a postcard about your late listing, please stop by our office to sign the form. LISTING FORMS MUST BE RETURNED EACH YEAR EVEN IF EVERYTHING REMAINS THE SAME! Listing forms allow our office to know who owns personal property, keep up with any changes made through the year, and have the ability to list these items to the correct owner. This is especially important for anyone who got rid of any personal property last year!

Individual Personal Property Items to be listed include: Boats, permanently tagged trailers, ATV's, IRP's, crab Pots, aircraft, mobile homes, fish nets, household rental items for long or short term rentals. *NOTE: Vehicles tagged annually should NOT be listed!
