# Recommend That Stikeleather and Walker Be Retained in Pres-ent Positions



### FUNERAL AT MURPHY FRIDAY AFTERNOON

Was Well Known Barrister And Leader in Section and State For Many Years

Hon. John Henry Dillard, 69 years old, prominent Murphy lawyer and Cherokee County's representative in the present session of the General Assembly, died at Reidsville, N. C., early Wednesday morning as a re-sult of an attack of influenza con-tracted during the Christn's holi-dars

thys. Shortly before Christmas, Mr. and Mrs. Dillard went to Reidsville to visit his sister. From there Mr. Dil-hard planned to po on to Raleigh in Junuary as Romesentative of Cher-oke County. Shortly after arriving at Reidsville he was forced to take his bed with an attack of the flu. Other complications set up and he gradually grew weaker. Physicians attending him gave up hope for his r covery more than a week ago. Funeral services will be held from the Presoyterian church Friday af-termoon by his pastor, the Rev. Dr. J. P. Anderson.  John Henry Dillard was educated in a private school at Greensboro, N. C. where he was a school mate of the late Sydney Porter, hetter known as O. Henry, the beloved American Short story writer. Still later he attended the Finlay High School at Lenoir, where he complet-ed the course. Subsequently he studied under Prof. N. S.
