

ADVERTISEMENT FOR BIDS
Sealed proposals will be received by the Hospital Committee of District Memorial Hospital of Southwestern North Carolina, Inc., at the City Hall, Andrews, North Carolina, until 2:00 p. m., E. S. T., June 3, 1955, and immediately thereafter publicly opened and read for the furnishing of labor, materials and equipment entering into the construction of a new hospital building for District Memorial Hospital of Southwestern North Carolina, including drives, walks, equipment and appurtenances thereto. Proposals received after the hour and date specified above will not be considered.

Separate bids will be received for the General Contract, the Plumbing Contract, the Heating and Ventilation Contract and the Electrical Contract.

Complete plans, specifications and contract documents will be open for inspection at the plan rooms of A.G.C. and Dodge Reports in Charlotte, N. C., Greensboro, N. C., Greenville, S. C., and Atlanta, Ga., and in the office of Six Associates, Inc., Architects-Engineers, 1095 Hendersonville Road, Asheville, N. C. Plans, specifications and other contract documents may be obtained by prime contractors on or after May 6, 1955, upon deposit of \$50.00 in cash or check for each set of plans and specifications for General, Plumbing, Heating, and Ventilation, and Electrical Contracts. The full deposit will be returned to contractors submitting bona fide proposals, provided plans and specifications are returned to the Architects in good condition within five days after the date set for receiving of bids. Sub-contractors may obtain plans and specifications by making a deposit in the sum of \$50.00 per set. When the plans and specifications are returned in good condition, 50c for each plan sheet supplied the sub-contractor will be deducted from the original deposit, and the balance returned.

All Contractors are hereby notified that they must have proper license under the State laws governing their respective trades.

No proposals shall be considered or accepted by said board or governing body unless at the time of its filing the same shall be accompanied by a deposit with said board or governing body of cash or a certified check on some bank or trust company insured by the Federal Deposit Insurance Corporation in an amount equal to not less than 5% of the proposal. In lieu of making the cash deposit as above provided, such bidders may file a bid bond executed by a corporate surety, licensed under the laws of North Carolina to execute such bond, conditioned that the surety will, upon demand, forthwith make payment to the obligee upon said bond if the bidder fails to execute the contract in accordance with the bid bond and upon failure to forthwith make payment the surety will

pay to the obligee an amount equal to double the amount of said bid bond. This deposit shall be retained if the successful bidder fails to execute the contract within ten (10) days after the award or fails to give satisfactory surety as required herein.

Performance Bond will be required in the amount of One Hundred Percent (100%) of the contract price.

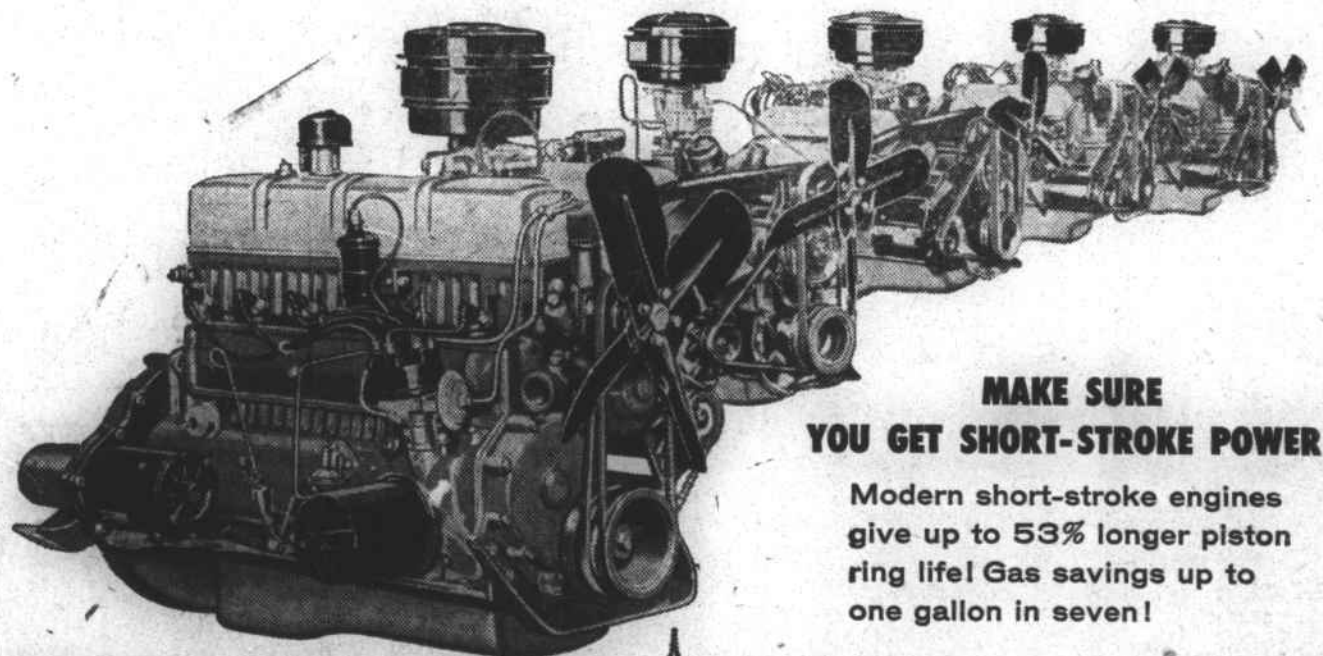
