

### Not Reprising Chessman, Says California Chief

SACRAMENTO, Calif. Unless there are unexpected developments of a truly critical nature, Gov. Edmund G. Brown will not halt Caryl Chessman's execution next Monday.

Brown read from the state Constitution Tuesday and then told his news conference: "I am constitutionally now prohibited from extending clemency."

He noted the State Supreme Court twice has refused to recommend clemency.
