


The Board Chairman shall be elected from two or more nominees from the newly elected Board. The nominee receiving the majority of votes shall be the Chairman.





the Secretary-Treasurer from performing his disbursing ducies, the Chirman of the Board shall be authorized, as directed by the Board, to sign checks for bills payable

DUTIES OF OFFICERS - The Captain shall be in complete charge of all equipment, training. and rescue missions. His duty and authority will be assumed in his absence by the next canking officer of each unit.

DUTIES OF THE BOARD OF DIRECTORS — The Directors shall act as the governing bdy controlling policies and expendi-tures, and shall determine methods of conductiong all activities according to the By-Laws.

The Board of Directors shail have the power to suspe d any member of officer within the units upon recommendation by officers of the unit to the Board of Directors.

Temporary suspension will be made immediately by officers at the time and place of infraction. with a fair hearing at a later date by the Board of Directors. officers, of the unit concerned and the member charged with the offense.
