RECIPE

Liver should be served once once a week because of its nutritional and iron content. This is one of the many ways liver can be served.

Liver Italiane

- 1 T flour
- 1/8 t seasoned salt
- 1/8 t seasoned pepper
- 4 slices beef liver
- 1/2 pound Italian Sweet-sausage links, cut into 1/2-inch slices
- salad oil
- 1/2 c catchup
- 2 T dry sherry
- 2 T Worcestershire
- 1 large onion, chopped
- 1 medium green pepper, chopped

Combine flour, seasoned salt and pepper; coat liver. In Dutch oven over low heat, saute sausage slices until browned, about 15 minutes; remove and set aside. To drippings, add 1 tablespoon oil, if needed, then add liver and brown on both sides, about 3 minutes.

In medium bowl, blend catchup, sherry, Worcestershire and 1/2 c water; pour over meat. Add sausage, onion and green pepper. Cover; simmer 10 minutes or until vegetables are tender-crisp. Baste occasionally.
