The Program--Legal Services of the Lower Cape Fear is a legal aid program rendering civil legal assistance to indigent individuals in eight southeastern North Caolina counties. Legal Services of the Lower Capr Fear provides advice and counseling to the 130,000 eligible clients it serves in the predominately rural eight counties of southeastern North Carolina, while concentrating its litigational and representational capacities in the areas of public benefits, education and job training, housing and housing development. This attorney will spend the majority of his or her time in representing indigent individuals and groups in the eight counties served by this program. Additionally, this attorney will render general assistance through a Telephone Assist-

tance Project to persons in a multiplicity of legal areas. There is an emphasis on legal education for low- income people, and all attorneys are

expected to assist in this area. Presently there is a central office in Wilmington, North Carolina. The primary method of service and intake is through a toll-free assistance number staffed by a licensed attorney each day, and providing the general assistance for a balanced program to the client population. The legal staff of the program consists of four attorneys and two paralegals.


