Employment and Training Counselor. This position is located in the Office of Participant Service unit of the Robeson County Department of Human Resources. This position functions as Employment and Training Counselor and involves enrolling, counseling, maintaining necessary records on and developing job sites for economically disadvantaged persons. Some of the duties include: assisting in the selection of eligible applicants, providing enrollees with general information about CEIA, compiling enrollment sheets, coordinating interview between worksite and eligible participants, updating Employability Development plans as necessary, being receptive to needs and providing information to participants on how to effectively handle problems, writing follow up reports after counseling sessions, and explaining CEIA programs to agencies and organizations.

Applicants will be considered to be minimally qualified for this position if review of their application indicated the applicant has the following knowledge, skills and abilities:

Knowledge of a wide range of counseling techniques. Knowledge of local educational resources and sources of available information useful in training. Ability to develop and communicate an organized plan of counseling. Ability to use audio-visual and written materials as aids to counseling. Ability to write precise detailed follow up reports promptly and accurately. Ability to express ideas and instructions clearly and concisely, orally and in writing. Ability to develop, compile, analyze, compose and edit course outlines, lesson plans, and training aids suitable for varied in-service and/or participant programs. Ability to disseminate data on participants. Ability to effectively communicate with people of varied social, economic, and educational backgrounds. Ability to maintain folders in a systematic method. Ability to follow written and oral instructions. Ability to exercise mature judgment and discretion in the establishment and maintenance of working relationships with supervisory personnel, government officials, labor market establishments and educational institutions. Ability and willingness to assist applicants in completing requirements to achieve training and employment goals.
