Race Rears its ugly head in the 7th Congressional Run Off, But Rose Marie Lowry-Townsend is Still Going to Win on June 4

Indians and Blacks in Robeson County are on the verge of selfdestruction, being played off against one another like ping pong balls. Congressional candidate Mike MeIntyre and his people, including his campaign manager. Lumberton attorney David Branch, are telling Blacks that Indians are "taking over everything in Robeson County". How foolish and untrue that sentiment is. Indians and Blacks are still woefully under represented in Robeson County. Racial division is being encouraged, even fanned into a roaring fire in some quarters. But we are not going to fall for it this time, whether the puppeteer is Mike McIntyre. Tom Jones, or a disgruntled Indian from New Jersey Many Indians and Blacks are trying to find out why they are lining up in such weird alliances. Never have we seen such strange, political bedfellows. For instance, the Black Caucus has endorsed Mike McIntyre for congress. but McIntyre doesn't know whether that is good or bad since the majority of his supporters are White, arch-conservatives like himself. Blacks arn't doing political hand stands either; many of them are embarassed about it. For instance. Tom Jones, the Black candidate, received a mere 67 votes in Mike McIntyre's Precinct. Lumberton #1 in the recent register of deeds race. Indians are frustrated, and concerned that the warped political turns might adversely affect Rose Marie Lowry-Townsend's bid for congress. Go figure. Only in Robeson!! See if you can follow this. The Black Caucus, with defeated Register of Deeds Candidate Thomas Tom Jones Jr as president, decided, after the primary to endorse Mike MeIntyre. Talk about sour grapes. Neither McIntryre nor the Black Caucus seem to want to brag about the endorsement too much. It seems that those Blacks who have fined up with Melntyre have done so because they are mad with Indians. As reported in last week's front page editorial. Jones, and his supporters. believed they had a solid commitment from the Indian community in the register of deeds race. They didn't. Vickie Locklear, an Indian, won the Democratic primary. Strange, huh? A few Indians have also decided, for what ever reason (God only knows!!), to support Mike McIntyre too, Why? We have no earthly RF ASON, or editorial RATIONALE for such a strange turn of events. Think about it! There are actually Indians and

Blacks in Robeson County who would rather have an arch-conservative White male from Lumberton represent them in congress than a liberal. female. Lumbee Indian from Pembroke Go figure! Only in Robeson!!! Some of us still, seemingly, want to be treated as children, the paternalistic approach suits us just fine. The question begs an answer do we

always think well of ourselves?

LET'S SUPPORT ROSE MARIE LOWRY TOWNSEND ANYWAY!!

Let's support Rose Marie Lowry-Townsend anyway, especially after we ask Mike MeIntyre the right kind of questions. For instance, will Mike McIntyre support the extension of the 1965 Voting Rights Act when it comes up shortly in Congress' Did you know that Robeson County is subject to the Voting Rights Act for past discriminatory practices? The Voting Rights Acts is what opened political doors for Indians and Blacks in Robeson County . Have any of us forgotten so soon? Also, another question you might ask Mike MeIntyre is. Does he support the Motor Voter Act? Wouldn't it be nice to be able to register to vote and get your driving license all at the same time? And, the third question we will ask him, if we get a chance before the election, is: is he in favor of affirmative action? All three of these agenda items will help (or have already helped) Indians and Blacks, and many Whites too. We should be asking the candidates questions like these: instead. McIntyre and his minions are spreading out across the district questioning Lowry Townsend's financial support, and whether or not she is a true daughter of Robeson County Why not ask her father Pembroke native and Rev Welton Lowry "He probably has a good answer to that question. Also, MeIntyre and his people ought to be asking Lowry-Townsend whether or not she has broken any election laws. She obviously has not. That question has never been asked. Why? MeIntyre and his people are frantically fanning the racial fires in Robeson County, hoping to split the Indian and Black informal coalition that has held sway in recent elections. MeInty re's only hope for victory is to throw political dirt on Rose Marie Lowry Townsend and split the Indian and Black electorates. We do not believe he will be successful. It makes one wonder why a man like. Mike

McIntyre, who talks about being a Christian publicly, and champions family values . would stoop so low as to talk disparagingly about Rev Welton Lowry's daughter Ummmmm!!!!!


