LONDON.

April 12. By the last mails from Lisbon, there are several advices in town, that the court of Portugal stop all ships loaded with corn which call in there, notwithstanding that market was so excessively glutted by a number of ships arriving in a short space of time, that the loss must be immense to the British traders; who, by advices from the Spanish and Italian markets, have reason to expect the most inviting success, if their ships were not stopped at Lisbon; for which the officers produce the king's decree, passed in 1757, never heard of before.
