An Act to prevent the unreasonable Destruction of Fish, &c .- 13. An Act to enable William Dry, Esq; to cut a Road across Eagle

Island.—14. An Act for altering the Dividing Line between Northampton and Hertford.—15. An Act for the Relief of Abraham Jones, late Sheriff, &c.—16. An Act to continue an Act therein mentioned.—17. An Act to prevent hunting and killing Deer in the manner therein mentioned.—To which Bills his Excellency gave his Assent.

From Charlestown we are advised, that the snow Eagle, James Hutton, master, who sailed from that port the 22d of August last for Antigua, with a cargo of lumber and 71 barrels of rice, overset in the night of September 8th, in latitude 28. 44. N. and longitude 65. 30. The people were 12 hours on the bottom of the veffel before the boat came up, on board of which they happily all got. On the third day afterwards the carpenter died, whose body they eat, after taking out his entrails. On the of day they cast lots in the boat, which of them should be killed for the sustenance of the rest; and as they were about to butcher the wretched victim, one of them elpy'd a vessel becalm'd, when they rejected their project, and immediately made towards her, and found her to be a vessel from North Carolina, which carried them into St. Christopher's, September 29th.

By a letter from Halifax in Nova-Scotia, we learn, that seventeen large boats have been seized by his Majesty's cutters on the Newfoundland station, for carrying British caught sish on board two French doggers on the Banks. As their whole cargoes were proved to be none of their own catching, they have been unladed at St. John's, and afterwards discharged.
