

THAT one of the biggest and strongest men the civilized world has rever known was born in Nova Scolia and finally died there about 70 years ago? His name was Angus McAakill and he was known as the Cape Breton Giant. He was 7 feet 3 inches tail; his girth was 60 inches and he weighed 425 pounds. It was his amazing strength that led to his death. On a bat he lifted off a pier in New York an anchor that weighed 2200 pounds. He had it over his head and was about to heave it into the water when one of the flukes caught in his shoulder causing an injury that brought about his death a few years later. Some relice of this giant are still in existence and included among them is one of his, shocs which is pictured in the above photograph.


