

after he had been admitted. The body bore 21 abrasion and contusions, and deep cuts in the wrists, lending observers to believe that he had been tied behind an automobile and dragged over rough ground.

The back of his head had been beaten so badly, it was describd as being as "soft as a ripe omato." The clothes were torn to shreds and the entire body was covered with dirt, further evidence that he had been dragg-

ed behind a speeding car.


4 and a period for registration will preceed the primary.




