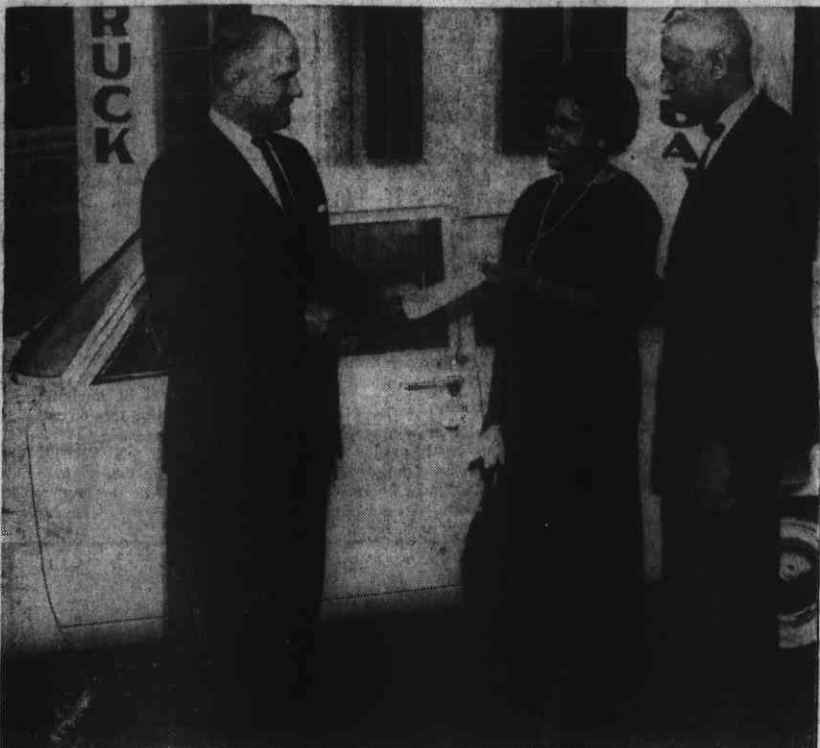


# New Car To Be Given At Shrine East-West Game

## Miss White Will Get '63 Falcon At Half Time of December 8 Tilt

Plans are being prepared to present Miss Hattie White, winner of the Carolina Times recent ly concluded subscription contest, with a new Ford Falcon at the halftime of the East-West High School Shrine Bowl game here on Dec. 8.

Miss White won the new automobile by finishing first in the contest which ended on Nov. 5. Mrs. Ruby Devine, Durham publicist, finished second, and Mrs. Maudie Dickerson, Margaretville merchant, placed third.

Mrs. Devine will get a color television set, and Mrs. Dickerson will be given \$300 in cash. L. E. Austin, publisher of the TIMES, announced this week the plan to award the first prize to Miss White at the East-West high school all star game.

He said preliminary negotiations with the game officials had already been completed. The game is an annual promotion of North Carolina Shriners to provide funds for its many philanthropic activities. It was held in Durham when the game was first organized several years ago, but had been played in Greensboro for the past two years.

The game pitting the best players from the East and West in an all star game, will be staged at County Stadium Saturday afternoon Dec. 8.

## CORE Readies Task Force For Action in Tenn.

CORE's newly established Freedom Task Force will go in to action December 1st in North Carolina and Tennessee following a final 2 day training period here in Durham.

The Task Force will be composed of long term volunteers, many of whom are college students. This was announced on November 15 by CORE Program Director Gordon Carey, who will lead the training session and coordinate the program.

"CORE has long felt the need for developing a corps of skilled volunteers to work in trouble spots and on special projects in the south," Carey explained.

"Last summer, we recruited approximately 25 volunteers for Freedom Highways, a project aimed at desegregating restaurants and motels along major auto routes. The success of this venture showed the feasibility of expanding this type of program."

The Task Force will begin with about 12 field workers and probably will be limited to about 40 during the first year of operation. In the communities See TASK FORCE, 6-A

## Edenton Leader Is Released From Jail

EDENTON — Golden A. Frinks, a civil rights leader here, has again been released from jail on bond, after serving 11 more days of a 30 day sentence for contempt of court. He had previously served 11 days of the sentence in September, before bond was set by the North Carolina Supreme Court; and when this court refused to reverse his conviction in early November, he went back to jail.

Bond was reset when Attorney G. E. Tillett appealed the case to the U. S. Supreme Court. Widespread protest had poured into North Carolina over the re-jailing of Frinks.

The contempt of court charge against Frinks resulted from a misunderstanding in court in September. Frinks has been one of the leaders in the growing movement to end segregation in Edenton.

Meantime, four persons arrested for picketing in violation of Edenton's new ordinance limiting picketing were sentenced on November 14 by Recorder Judge W. S. Privott to 10 days in jail, with a provision that the sentence be See RELEASED, 6-A

## CORE Head Asks More Sit-ins In Greensboro

GREENSBORO — James Farmer, National Director of the Congress of Racial Equality, urged Negroes here Sunday to continue demonstrations despite whole sale arrests by police.

Farmer described as "most regrettable" the arrest on Saturday of 50 CORE members who staged a demonstration at S and W and Mayfair cafeterias. "I feel confident CORE will continue to fight for rights which we feel Negroes deserve," Farmer said at Sunday night's mass meeting.

The 50 who were arrested Saturday were not required to post bond and were released for appearance in municipal court on Nov. 27. Most were faculty See CORE, 6-A

CHARLOTTE — A prominent civil rights attorney of South Carolina said here Sunday that the "sit-in" movement has lost its usefulness.

He was Atty. Matthew J. Perry, of Columbia, who was addressing an Omega Psi Phi Achievement Week program at Johnson C. Smith University.

## Auto Wreck of Roxboro Teeners Is the Bloodiest

Six persons were killed in four separate automobile accidents throughout the state over the past week-end.

In one of the bloodiest of the four crashes, two youths died and four others were injured in an accident near Roxboro. All were teenagers except one.

The dead were Cordell Graves, 18, and William Henry Garnette, 21, both of Roxboro.

They were killed when the automobile in which they were driving went out of control and ran into a ditch on N. C. highway 49 near Roxboro.

Injured in the wreck were Gertrude Graves, 19, sister to the dead girl; Ida Lee Cunningham, 17; Linda Faye Newman, 14; and Oscar Carver, 19, all of Rt. 2, Roxboro.

Funeral services for Garnette were scheduled for Tuesday, and the girl, Miss Graves, was to be buried on Thursday.

Two Weldon men died late Saturday in a wreck near Greenville and an Oxford man was killed in Vance County.

David George Winbush, 25 year old resident of Rt. 1, Oxford, died when his speeding auto overturned on a rural paved road eight miles north of Henderson.

The bodies of Horace Cole Purnell, 35, and Grant Park, 36, both of Weldon, were discovered early Sunday morning by a work crew.

The men were found in their automobile which had gone out of control, jumped a creek and plowed into a bank 65 feet away.

The accident, which apparently took place late Saturday night was not discovered until around 7 a.m. Sunday morning when a work crew went to sow grass on the bank.

The accident occurred on U. S. 18, at Grinie Creek, seven miles north of Greenville. Investigating patrolmen estimated from skid marks on the highway the speed of the car at about 80 to 100 miles per hour shortly before the crash.

A nearby resident said he heard a noise about 11 p.m. and checked along the road but did not find the car.

In Wilson, a 40 year old man, Andrew Baker, of Stantonburg, was killed when he was struck by a car while walking along U. S. 301 north of Wilson.

His mangled body was struck immediately by a second car, driven by a honeymooning couple, Mr. and Mrs. William Wilson, of Wilmington, Del.

But officers said the Wilson car could not avoid hitting the man.

Police were still searching early this week for the driver See WRECK, 6-A
