HENDERSON NAMED COMMISSION CHAIRMAN HOUSING AUTHORITY


Five New Commissioners Join Incumbent Midgette, Plummer

J. J. Henderson, former vice chairman of the Durham Housing Authority, was chosen as new Chairman after the installation of five new board members. This brings the Commission total to 7 members. Special legislation by the General Assembly provided the change in membership as well as the selection of members. The full Durham City Council was authorized to make the selection instead of the Mayor. Henderson, a vice president and Treasurer of North Carolina Mutual Life Insurance Co. had previously served for 19 years with the Authority. It was emphasized by Henderson, after his election as Chairman, that he would need the full support and cooperation of all its members. He expressed the idea that this would be a team job and a team program. The diversity of backgrounds would afford credit and expertise to the new commission was also mentioned by Henderson.

Black Leaders, Educators To Meet in Bricks

WARRENTON — Black educators, parents and community leaders from all over North Carolina will meet Oct. 9 at the Franklinton Center in Bricks, for the first North Carolina Conference on Early Childhood Education. Sponsored jointly by the Franklinton Center (formerly Bricks College of the United Church of Christ). The Black Child Development Institute of Washington, D. C., and the Economic Development Corporation, with headquarters in Warrenton, the three-day conference is designed to launch an organized effort to assist the state's Black Child Development Centers in providing optimum child care. J. C. Scarborough, Sr., longtime businessman, founder and builder of the Scarborough Hargett Funeral Service of Durham, N. C., was highly honored at the 34th annual meeting of the National Funeral Directors and Morticians Association held recently in St. Louis, Missouri. He was presented with a Life Membership in the Association.

Scarborough was the founder of the State Association in June, 1928 at the meeting held in Wilmington, N. C. This first annual session, known as the Colored Undertakers and Embalmers' Association with J. C. Scarborough, Sr. as advisor is now known as N. C. Funeral Directors and Morticians Association.

Scarborough, in the true tradition of the frontier settler, began his Durham Business career in 1907, just one year after his graduation from the Renouard School of Embalming. His first venture in the funeral service business at the managerial and ownership level was in 1888, when Joseph C. Hargett, a successful merchant of Kinston, N. C. provided the necessary capital. Scarborough

married Hargett's daughter. This union produced a son, J. C. Scarborough, Jr. and a daughter, Mrs. Ernestine Bynum.

During his sixty odd years of service, he has served as director of Mechanics and Farmer's Bank since its organization and is still serving. He has been a director of the Banker's Fire Insurance Company and President of the Southern Fidelity Mutual Insurance Company since its organization. Urban League Pushes Health Project in South

ATLANTA, Ga. — Mrs. Ruth Akins, National Urban League Associate Director for Health, visited Atlanta September 29-30 to confer with staff of the League's Southern Regional Office concerning a new federally-funded program aimed at improving health services available to poor and minority people throughout the nation.

Entitled "Enrichment of Community Health Programs," the project is designed to aid communities experiencing problems in implementing already approved U. S. Department of Health, Education, and Welfare (HEW) financed comprehensive health services programs. It is anticipated that the project will ultimately serve two to three communities.
