### Curtains Come Clean

Dear Virginia White:  
Now that we're getting some spring sunshine, I can really see how badly my fiberglass curtains need cleaning. Can I launder them at home?

Cautious

Dear Cautious:  
If your washing machine has a gentle cycle, you may wash your fiberglass curtains in it. If not, wash them by hand, using gentle agitation to prevent the fibers from breaking. Soak the curtains in hot water for 15 hours with 2-cup Miracle White Super Cleaner, 1/2-cup non-chlorine bleach, and 1/2-cup detergent. Rinse in cool water and drip dry. Don't wring out excess water, because this may break the fibers.
