

Curtains Come Clean Dear Virginia White:

Now that we're getting some spring sunshine, I can really see how badly my fiberglass curtains need cleaning. Can I launder them at home? Cautious

Dear Cautious: If your washing machine

has a gentle cycle, you may wash your fiber-



it. If not, wash them by hand, using gentle agitation to prevent the fibers from breaking. Soak the cur-

tains in hot water for 1/2 hour with 3;-cup Miracle White Super Cleaner, 34-cup non-chlo-rine bleach, and 12-cup detergent. Rinse in cool water and drip dry. Don't wring out ex-cess water, because this may break the fibers.

Dear Struck Out: Here's the way to get to first base with those tough stains. For the mustard stain, make a detergent paste by moisten-ing a small amount of your favorite laundry detergent, or mine-I prefer Miracle White Non-Phosphate Detergent, with water. Use a soft brush to work the detergent paste into the stain.

Pretreat the catsup stain by Pretreat the catsup stain by sponging with cold water. Then, for both stains, launder in the hottest water the fabric will allow with ¼-cup deter-gent, ¼-cup non-chlorine bleach, and ¼-cup Super Cleaner. That should knock your stain problems right out of the park.






