The special highlights the celebration commemorating "National OIC Day." Proceeds from the celebration will be used to further the OIC nation campaign for employment among this nation's disadvantaged citizenry.

Opportunities Industrialization Center is a national organization dedicated to occupational training for disadvantaged Black, White, Indian, and Mexican-American people. Started in 1964 by Dr. Leon Sullivan, OIC has trained over 116,000 people in useful skills. In the process, they have added over \$500 million to the nation's economy, and saved over \$100 million in welfare payments.
